

Kingfield Selectmen Meeting Minutes

Monday August 1st, 2016; 6:00 PM Webster Hall 38 School Street

Chairman Browne opens meeting at 6 pm. Warrants and meeting minutes are passed around. Motion made by Selectman Hatfield to accept minutes as written, Selectmen Meldrum Seconds. All in Favor.

Old Business: Chairman Browne asks if the board is ready to talk about the Stanley Museum lease. Selectman Meldrum says they should have another week to look at it. All in Favor.

Next is the committee guidelines that Leanna has written up. The board agrees that this too, should be put off until the next meeting.

The Community Network agreement is next on the agenda. Chairman Browne says that Leanna said it is a good thing and we should renew our membership. Selectman Dill makes a motion to accept. Selectman Meldrum seconds. All in Favor. Agreement is passed around for all to sign.

New Business: Chairman Browne says that he has talked to Harris Pumping and they only charge \$125 per 1000 gallons septic tank. He says the town should look into this as it might be cost effective to the town to go this route.

Selectman Hatfield says that he would like to have Leanna come up with the total cost of pumping out a tank to use as a baseline and go from there. Chairman Browne says that Harris pumping would be willing to come in and talk to board. The board agrees that Leanna should set that up.

Erica is recognized. Erica explained that normally Leanna lets the board know about these things, but since she isn't here, Erica wanted to be sure the board knew that 124 - 30 day lien notices went out totaling over 143,000 in taxes and fees. Selectman Hatfield asks if she is telling them because she is concerned. Erica says no, I know Leanna always makes sure you know when these notices go out, so she was trying to keep them informed.

Erica also tells Chairman Browne that she did indeed look into on-line vehicle registrations, but feels the cons, like losing up to 4,000 plus agent fees a year is not worth it. Also people like to come into the office.

ACO, Paul White is recognized next, he gives the ACO report. 3 cats and 2 dogs went to the shelter this month. He has also given out a dangerous dog notice and has followed up with them as they have not kept the dog on a leash or penned in as notice requires.

No other business, Selectmen Meldrum makes motion to adjourn. Seconded by Selectmen Dill. Meeting adjourned at 6:35pm.
