Meeting called to order at 6:00pm.

Board reviews the September 16, 2021, meeting minutes. Ray Poulin makes a motion to accept meeting minutes. Seconded by Wayne Rundlett. All in Favor.

Board then reviews financials. Ray Poulin makes a motion to accept financials as presented. Seconded by Wayne Rundlett. All in Favor.

Chairman Kilbreth recognizes David Taylor to provide a manager report to the board. David informs the board that Warren fixed the floor in the office and also moved the pump over. The Backhoe still has issues, the tires are losing air, hydraulics, door latch and more. Chairman Kilbreth asks if David has check with anyone since the last meeting. Chairman Kilbreth says with the rising cost that will continue to go up for hauling and tipping he suggests someone look into going back to a landfill.
